Advancing spatial justice in age-friendly work

White Room

Key issues for advancing age- friendly futures in research and policy implementation. Presentations setting out two principal challenge areas:

- Understanding and creating places for equitable urban ageing. Exploring the challenges of designing, implementing and evaluating Age Friendly Cities and Communities programmes.

Stefan White is a Professor of Architecture at the Manchester School of Architecture, Manchester Metropolitan University. He directs A3RO, focusing on interdisciplinary architectural research addressing global challenges like population ageing, urbanisation, and health inequity. He leads the Design for Life consultancy with Pozzoni Architecture and heads the Healthy Ageing Collaboration group at MMU.

Tine Buffel

Professor of Sociology and Social Gerontology & Director of Manchester Urban Ageing Research Group (MUARG)

Tine Buffel, a Fellow of the Academy of Social Sciences and Professor at the University of Manchester, directs the Manchester Urban Ageing Research Group. Her work focuses on social and environmental issues related to ageing, especially inequality, exclusion, and justice. Known for her participatory research methods, she works with older people, local authorities, and communities to create age-friendly environments.

Dr Mark Hammond

Senior Lecturer, Manchester Metropolitan University (MMU), Manchester School of Architecture (MSA)

Dr. Mark Hammond is the Deputy Research Lead at Manchester School of Architecture. His research examines architecture and urban ageing, focusing on housing inequality and spatial justice. From 2018-2021, he was seconded to the GM Ageing Hub to help develop their Housing, Planning and Ageing programme. He currently leads the 'Co-Creating Age-Friendly Social Housing' project.



Ryan Woolrych

Professor in Ageing and Urban Studies, Heriot Watt University

Ryan Woolrych is a Professor in Ageing and Urban Studies at Heriot-Watt University, focusing on inclusive supports for healthy ageing. He leads cross-national research on age-friendly cities, especially in the Global South with case studies in India, Brazil, and Colombia, using participatory methods to study ageing and place.Professor Woolrych has secured major UK research funding and currently researches place-based inequalities among Roma populations.



Dr Emi Kiyota Associate Professor, National University of Singapore

Dr. Emi Kiyota, an environmental gerontologist with over 20 years of experience, specializes in person-centered care and transforming organizational culture in long-term care facilities worldwide. She founded Ibasho in 2010 to create elder-led community hubs in Japan, Nepal, and the Philippines. Collaborating with the World Bank and WHO, she works on improving aging services in low-middle income countries. Her areas of focus include socially integrated cities, aging in place, brain health design, and aging's intersection with climate change.



Judith Phillips

Professor of Environmental and Social Gerontology, University of Stirling

Judith Phillips is Professor of Social and Environmental Gerontology at the University of Stirling. Between 2020 and 2024 she was the UKRI Research Director for the Healthy Ageing Challenge, held alongside her position as Deputy Principal (Research) at the University. She has published and researched widely on environmental aspects of ageing, social care and caregiving. In 2013 she was awarded an OBE for Services to Older People.



Dr Beatriz Fernandez

Associate Professor, Urban Studies, The School of Advanced Studies in Social Sciences (EHESS), Paris

Beatriz Fernández, an urban planner and Associate Professor at EHESS in Paris, researches demographic shifts in cities, focusing on aging, urban change, and planning policy. She leads two projects: EnversMet (funded by ANR) studies population aging and agefriendly policies in Paris and Madrid; SeniorSolitude (funded by Paris) compares strategies to address loneliness among older adults in Paris, Sapporo, Montreal, Toronto, and Madrid. She was a visiting scholar at Doshisha University in autumn 2024.



Dr Jo-Pei Tan Senior Lecturer, Integrated Health and Social Care, MMU

Dr. Jo-Pei Tan, Senior Lecturer in Integrated Health and Social Care at Manchester Metropolitan University, has over 20 years of experience in applied psychology and public health. Specialising in intergenerational ties and care relations, she holds a DPhil in Evidence-based Social Intervention. Her research on equitable aging uses innovative methods to address health inequalities and care provision challenges. Dr. Tan's interdisciplinary work has earned her recognition as a keynote speaker for the British Society of Gerontology's 2025 Annual Conference.

Panel 2: Co-creating inclusive age-friendly cities: Research across disciplines and sectors

Prof Joost van Hoof

Professor of Urban Ageing, Faculty of Social Work & Education of The Hague University of Applied Sciences

Joost works as a full professor of Urban Ageing with the Faculty of Social Work & Education of The Hague University of Applied Sciences in The Netherlands. Since December 2017, he has also been affiliated with the Department of Systems Research of Wrocław University of Environmental and Life Sciences in Poland. Professor Van Hoof is the Chairperson of the Knowledge Platform Age-friendly The Hague, which conducts the bi-annual assessment of the age-friendliness of the city for the municipality.

Rahimah Ibrahim

Associate Professor, Malaysian Research Institute on Ageing (UoM)

Rahimah Ibrahim is a prominent gerontologist and aging policy expert, leading the Malaysian Research Institute on Ageing (MyAgeing®) at Universiti Putra Malaysia. She influences Malaysia's aging policies through her roles in the National Councils on Ageing and SUHAKAM. As Deputy Chairman of KENDANA and Deputy President of the Gerontological Association of Malaysia, she advocates for caregiver rights and interdisciplinary collaboration. Her initiatives focus on age-friendly cities and aging-in-place solutions. Dr. Rahimah promotes intergenerational solidarity and integrated health-social care, guiding evidence-based policy development and sustainable strategies for future generations.

Neil Dagnall

Professor in Applied Cognitive Psychology, MMU

Professor Neil Dagnall researches applied cognitive psychology, focusing on how people process information, make decisions, and respond to uncertainty. His work examines cognitive factors influencing memory, reasoning, and behaviour change, with applications in performance, wellbeing, and risk assessment. He explores how individuals evaluate information across contexts to enhance adaptive decision-making. His research applies psychology to real-world settings, including education, health, and occupational performance. Neil also studies lived space, contributing to projects that improve housing choices for older adults and inform urban planning.

Nicola Waterworth leads the Ageing in Place Pathfinder in Greater Manchester and works on Greener Later Life for the Ageing Hub. Chief Executive (Bury Council) and Greater Manchester Portfolio Lead for Equalities Lead -Ageing in Place at GMCA

Lynne is CEO of Bury Council; place lead for gm NHS services in Bury and GM portfolio lead for equalities. Lynne led the development of the Bury community strategy – LETS do it! – a call for public, private and community sectors to work together and improve the lives of local people. Lynne is an HR professional by background and a fellow of the cipd; committed to equalities, she was formerly vice chair of a major GM charity supporting disabled people. 17

Thiago began his career as a physical educator for older adults in Brazil's healthcare settings. Since 2010, he has been a researcher in Brazil and the UK, publishing in major journals. He joined WHO in 2017 to support urban, transport, and health initiatives. In 2022, he started leading Age-friendly environments at WHO, coordinating the Global Network for Age-friendly Cities and Communities, developing national program guides, and supporting WHO Member States.

Sir Richard signed the city-region's health devolution deal in 2015. He led Greater Manchester Health and Social Care Partnership from March 2020 before chairing NHS Greater Manchester Integrated Care. He has also chaired Manchester's Health and Wellbeing board, Manchester, Salford, and Trafford Health Action Zone, addressing health inequalities. A strong advocate for addressing the determinants of health, Sir Richard believes partnership working is key to this and public service reform. Involved with the reference city of the Amsterdam metropolitan area since 2016. Building leadership through economic growth and development

This panel will investigate the strategies that age-friendly programmes can adopt to speak to economic growth and development agendas.

Panellists will discuss the economic opportunities of ageing populations for city regions, as well as key priorities around ageing and innovation. This panel will identify strategic drivers and discuss how to position ageing work within economic and development opportunities for cities and city regions.

Dr Emily Andrews Deputy Director for Work, Centre for Ageing Better

Emily leads the Work team at Ageing Better, focusing on fair work access for people aged 50+. They manage the Age-friendly Employer Pledge network of over 450 employers. They collaborate with employment support providers, local commissioners, and policy-makers to promote system change, including evaluating Working Well: Support to Succeed with GMCA. Previously, Dr. Andrews was Associate Director at the Institute for Government, studying public service spending constraints post-2010. She holds a PhD in History from the University of Warwick and began her career as a secondary school teacher.

Chief Executive, International Longevity Centre – UK

David has 20 years of experience in policy and research on ageing and demographic change. He focuses on older consumers, active ageing, financial services, adult vaccination, and technology in ageing societies. With over 30 years in healthy ageing and brain capital research, Lynne specializes in data and AI. She also co-leads the International Dementia Innovation Hub and is a Trustee of the Lewy Body Society.

The Covid pandemic had a significant economic impact on some businesses and residents, prompting Angela to lead the response for atrisk residents and develop the city's Anti-Poverty Strategy while contributing to the broader economic strategy.

With a focus on those who are not in paid employment and may have barriers to work, we are looking at new ways to design and deliver employment related activity.

She focuses on increasing access to physical activity and develops health programmes for Manchester residents. At GLL Manchester, she supports 21 facilities, including national centres and community hubs, ensuring strategic planning and stakeholder collaboration to promote healthier lifestyles.

Dying well in Age-friendly Communities

An Age-friendly Community is one that works for people across the lifecourse, and supporting end of life and dying well is no exception. Mary Hodgson is the Director of Inclusion & Social Innovation at St Christopher's. She leads efforts to address health inequalities and enhance community involvement in healthy dying. With a research and social innovation background, Mary has worked for LSE, The Young Foundation, Shelter, and various universities. She specializes in partnership working and holds a PhD in Anthropology.

Building Age-friendly and Inclusive Rural Communities

Boardroom

Older people living in rural areas can face challenges around staying connected (digital and transport), accessing health and care, or the right housing. Climate/weather factors can also have an outsize impact. At the same time rural areas can be great places to grow older. Older people form the backbone of many communities and report greater health and wellbeing than urban areas, as well as access to the great outdoors.

This panel shares learning from rural communities across Wales, Ireland and the Nordic region on how to continue to thrive at any age despite, and sometimes because, of the challenges.






